PARKING RULES AND REGULATIONS

All students are required to display a valid GCC Parking Permit on any vehicle which is parked on the campus. There is no charge for a Parking Permit . Permits are obtained in the GCC Library. The Permit is to be placed on the inside of the front windshield attached behind the rear view mirror or dashboard to be in view and so it does not obstruct vision to the road.

DESIGNATED HANDICAPPED PARKING SPACES THROUGHOUT THE CAMPUS ARE TO BE USED ONLY BY INDIVIDUALS WITH HANDICAPPED PARKING PERMITS ISSUED BY NEW JERSEY MOTOR VEHICLE COMMISSION, OR THE DEPTFORD POLICE DEPARTMENT. VIOLATORS MAY BE TICKETED AND TOWED BY DEPTFORD POLICE OR THE FIRE DEPARTMENT.

Please observe signage as posted on campus and as described herein

- 1) **Observe 20 mph posted speed limit** while driving on campus
- 2) Stop for pedestrians in the crosswalks
- 3) Lock your car, take the keys and place valuables out of sight.
- 4) Drive only on paved roads designated and authorized
- 5) **DO NOT PARK** in restricted lots, fire, or handicapped zones or on grass
- 6) Parking Permits are to be displayed while on campus
- 7) Parking Permits are non-transferable and, are to be returned to security when ownership has changed or a new Permit is issued.

Parking violations subject to fines:

1. Parking in restricted lots, or roadway other than designated, or failure to move vehicle when directed.
2. Parking in handicapped space/fire lane/sidewalk/grass/near buildings or blocking sidewalks
3. Parking near or blocking trash containers, construction area, delivery or any other vehicles
